

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to silverstonecapital.com, and governs data collection and usage.

Silverstone capital website is an eCommerce site. By using Silverstone capital website, you consent to the data practices described in this Statement and all extensions and addendums to this Statement.

## **Collection of your Personal Information**

In order to better provide you with products and services offered, Silverstone capital may collect personally identifiable information, such as your:

- First and Last Name
- Home Address
- Mailing Address
- E-mail Address
- Phone Number
- Financial Information

If you purchase Silverstone capital products and services, we collect billing and credit card information. This information is used to complete the purchase transaction or issue payments to you. We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstake or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. To with, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future for the same purpose.

## **Use of your Personal Information**

Silverstone capital collects and uses your personal information to operate and deliver the services you have requested. Silverstone capital may also use your personally identifiable information to inform you of other products or services available from Silverstone capital and its affiliate

## **Sharing Information with Third Parties**

Silverstone capital may sell, rent, or lease customer information to third parties for the following reasons: We will collect this data and provide it to third parties if it is a necessary step in the User account creation process, contributes to the ease of use, reliability, or functionality of our products, or if it is of mutual interest to Silverstone capital may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. Silverstone capital may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Silverstone capital, and they are required to maintain the confidentiality of your information. Silverstone capital may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Silverstone capital or the Site; (b) protect and defend the rights or property of Silverstone capital; and/or (c) act under exigent circumstances to protect the personal safety of users of Silverstone capital, or the public.

## **Tracking User Behavior**

Silverstone capital may keep track of the websites and pages our users visit within Silverstone capital, in order to determine what Silverstone capital services are the most popular. This data is used to deliver customized content and advertising within Silverstone capital to customers whose behavior indicates that they are interested in a particular subject area.

## **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by Silverstone capital. This information can include your IP address, browser type, domain names, access times, and referring website addresses. This information is used for the operation of Page 3 of 5 services, to maintain the quality of the service, and to provide general statistics regarding the use of the Silverstone capital website.

## **Use of Cookies**

Silverstone capital website may use cookies to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you and can only be read by a web server in the domain that issued the cookie to you. One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Silverstone capital pages, or register with Silverstone capital site or services, a cookie helps Silverstone capital to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on.

When you return to the same Silverstone capital website, the information you previously provided can be retrieved, so you
